
New CT Lung Cancer Screening Order and Revised Workflow **November 21, 2023**

New CT Lung Cancer Screening Order and Workflow Overview

Positions Impacted: All Providers who may place **CT Lung Cancer Screening** orders.

Effective 11/22/23: A new order format will be applied to the CT Lung Cancer Screening order that includes several **required fields**. These fields validate that the patient meets the appropriate criteria to receive the test based on their age, insurance, and smoking history.

Important Note to Clinical Staff: *The current task and the CT Lung Cancer Screening Referral Form will be removed. Instead, this information will be entered directly on the order.*

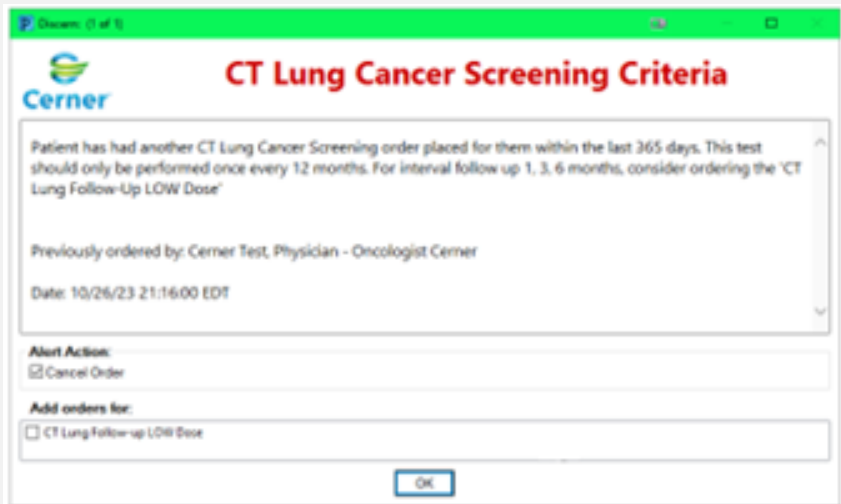
New CT Lung Cancer Screening Order Notifications

There are new order notification rule guidelines that have been added to prevent the placement of this order if the patient does not meet the criteria. If you see these notifications/guidelines, please review them, and proceed accordingly.

Example Order Notifications:

Alerts the Provider if a previous 'CT Lung Cancer Screening' order has been placed for this patient within the past 365 days.

- Provides information on who placed the previous order and the date/time it was placed.
- Will not trigger if previous exam was canceled or not performed.



- Evaluates the patient's age and insurance. Alert displays if the patient does not meet the current criteria to receive the screening.
