

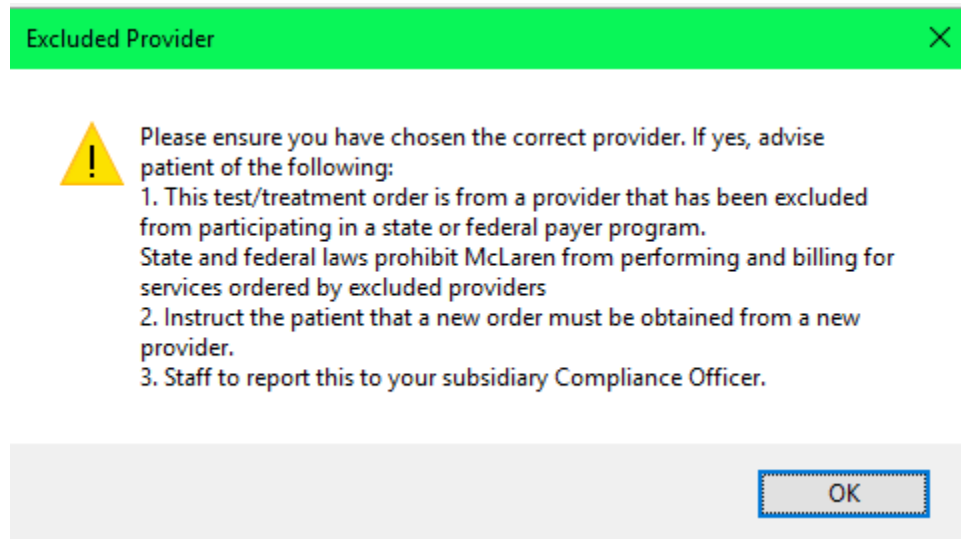

Excluded Providers in Registration/Scheduling

Starting on October 17th, 2022, registration and scheduling will now receive a pop-up in the system when a provider is selected in the system who has been prohibited from participating in state or federal payor programs. McLaren Health Care is prohibited from performing and billing for services that are ordered by these specific providers. The pop-up will look like this:



Patients should be instructed to obtain a new order from a new provider and the registrar/scheduler should report this interaction to their local compliance department. If a patient has any questions, please refer them to the local compliance department. Contact information can be found below.
